Box 3711), Montgomery, Alabama, until 2:00 p.m., CDT, Thursday, January 24, 2019 for FMTC Buildings 1023 and 2281 Classroom Electrical and IT Installation, Anniston, AL (IFB # AC-19-B-0004-S), at which time they will be publicly opened and read in the Second Floor Classroom (Room 201), of the State Military Department, 1720 Cong. W.L. Dickinson Drive, Montgomery, Alabama.
