

**Pursuant to Alabama Act No. 2001-956**, the Armory Commission of Alabama is seeking qualified Architectural/Engineering (A/E) firms to provide professional design services for the renovation, repairs and minor construction at various National Guard facilities throughout the state of Alabama under open-end contracts.

**Description:** The scope of work involves the design and construction administration for the sustainment, revitalization, and modernization at Alabama Army National Guard Readiness Centers, Field Maintenance Sites, Consolidated Support Maintenance Sites, and Alabama Army National Guard Training Centers. Environmental services may also be provided for the various facilities under this proposal. Typical projects and budgets include: Renovations/Restorations (\$250,000 to \$3,750,000), Metal Building Construction (\$100,000 to \$850,000), Site Improvements (\$100,000 to \$1,000,000), Shell Repairs (\$150,000 to \$850,000), Energy Conservation Improvements (\$100,000 to \$925,000), Access Control Systems (\$25,000 to \$150,000).

**Qualification:** A/E firms and all proposed consultants shall hold a professional license in the State of Alabama. A/E teams should be multi-disciplined and capable of complete project design. Successful firms shall be capable of managing multiple projects simultaneously. All firms shall have a permanent office located within state of Alabama.

Project design may include applying the principles and practices of sustainable design and development. Additional considerations may include interior design for finishes and furnishings and the latest anti-terrorism / force protection requirements.

**Application:** The Armory Commission of Alabama utilizes a process similar to that outlined in the Manual of Procedures, prepared by the Alabama Building Commission, to appoint selection boards and evaluate the candidate firms. The selection board will provide a recommendation to the Armory Commission of the most qualified firms for this project.

This Selection Process is in accordance with Section 41-16-72(3), Code of Alabama, 1975, as amended.

**NOTE:** A/E firms **MUST** follow the Selection Criteria Format identified in order to be eligible for selection. Failure to follow this format may result in rejection of A/E firm's packet.

**Selection:** No more than six A/E firms will be selected for this open-end service.
